bid of \$103,360 from Consolidated Disposal Systems for
a Peterbilt truck, 45-day delivery, for the
5 Maintenance Department. The motion was seconded by
Councilwoman Pittman. Motion passed by unanimous
6 vote.

7 A motion was made by Councilman Bates to approve the
mid-year budget review. The motion was seconded by
8 Councilwoman Pittman. Motion passed by unanimous
vote.

10 A motion was made by Councilwoman Alexander to approve
bidding procedures and issue RFPs for Autumn Park and
English Oak Park. The motion was seconded by
11 Councilman Roche. Motion passed by unanimous vote.

12 A motion was made by Councilwoman Pittman to approve

13 with corporate sponsorship and at no cost to the City,
on May 17th. The motion was seconded by Councilman

 17 working out billing procedure. The motion was

 motion was seconded by Councilman Spangler. Motion
 20 passed by unanimous vote.
