**YARD/GARAGE SALE REGULATIONS**

- Every person desiring to conduct a yard sale must submit an application with the City Clerk's Office with the applicant being the person residing at the site of the sale. There is a \$5.00 administrative fee for yard sale permit.
- The permit must be posted on the site during the date(s) of the sale.
- A permit shall only authorize an applicant to conduct a yard or garage sale for three (3) days.
- Each household, which shall include all residents of the household in the City of Doraville, is limited to three (3) yard or garage sales during a calendar year.
- Signs shall be placed only in the locations set out in the application for a permit and shall be limited to six (6) signs for that particular sale. No sign shall exceed two and one-half (2½) square feet of area.  
\*\*Signs are not allowed in any right of way, attached to trees, or directional signs/signals for any reason. The only location signs are allowed are the subject property or yards where permission has been granted\*\*
- After the sale, all the trash must be collected as well as all signs advertising the sale placed at other locations shall be removed within twenty-four hours after the conclusion of the sale.
- Any person conducting a yard sale shall be responsible for the street being kept clear for safe traffic movements.
- Yard and garage sales will be allowed for the sale of household goods and clothing of the household or households of the person or persons conducting the sale.
- A yard or garage sale shall only be held on the premises occupied by one of the persons conducting the sale. No person, household, group or organization involved in the sale of such goods shall offer for sale other goods which have been purchased for the purpose of resale.
